Tracy Student First in State to Earn ProStart National Certificate of Achievement

Chad Cooreman of Tracy Area High School is the first student in Minnesota to obtain national certification in the ProStart Program. Chad is a 2007 graduate of Tracy Area High School and



is currently enrolled as a freshman at Minnesota State University Mankato. He took his portfolio to an interview and was hired at an assisted living facility near the college. Chad competed on the Tracy Area High School Culinary Team at the Minnesota ProStart competition held last March in conjunction with Culinary Skills Challenge at Southwest Minnesota State University in Marshall. "The (ProStart) class is full again this year with all seniors who are ready to work hard and have fun in this new and exciting program," said Tami Wee. Congratulations to both Chad and Tami!

The ProStart® program, administered by the National Restaurant Association Educational Foundation (NRAEF), provides high school students with an opportunity to explore career options in the restaurant and foodservice industry through academic and work-based learning. The two-year program teaches students the management skills they will need to progress in their education and careers. When students meet academic standards, complete a checklist of competencies, and participate in at least 400 hours of a mentored work experience, they are awarded the ProStart National Certificate of Achievement that signifies they are well qualified to enter the industry workforce. ProStart works with leading college and university restaurant and foodservice management programs across the country to create articulation agreements that provide benefits to students who earn the ProStart National Certificate of Achievement.


employees, all with the goal of increasing the abilities and effectiveness of everyone.



Meg Litts, Coordinator of Curriculum, Assessment, and Instruction, and Ellie Helgeson, School Improvement Specialist, both with the SW/WC Service Cooperative in Marshall, recently spent two days in Litchfield working with a school leadership team as they participated in a data retreat.

The data retreat process, led by regional school improvement specialists, engages a school team in the process of examining multiple types of student data—primarily student achievement data, but could also include program, perception, or participation data such as attendance and discipline—to determine strengths and opportunities for growth in district/school programs.

Leadership teams participating in data retreat training learn to manage multiple years' data. Looking at data over a period of time allows the team to identify trends. The team will also drill down to skills/benchmarks to align state standards and local outcomes. From the analysis of the data, school teams will then set goals through action plans for addressing how the school can meet identified student learning needs through data driven decisions.

Data retreats are just one of many programs and services offered by the SW/WC Service Cooperative to school districts in southwest and west central Minnesota.


Approximately 650 participants attended the 15th Annual Conference for Young Writers on May 15, 2007 at SMSU in Marshall.





CHESS TOURNAMENT


The SW/WC Service Cooperative is sponsoring a new competition – a regional chess tournament. This competition was considered after interest was expressed by member schools.

2007-2008 MDE PROFESSIONAL DEVELOPMENT OPPORTUNITIES

PROFESSIONAL DEVELOPMENT TOPICS

(THESE TRAININGS WILL BE HELD AT THE SW/WC SERVICE COOPERATIVE IN MARSHALL)

Teacher Leadership I: Linking School Effectiveness and School Improvement Thursday, December 13, 2007, 8:30-3:00

Teacher leaders mobilize and energize others to sustain the vision of the school, with the goal of improving the school's performance. Issues which impact teachers as school leaders will be explored. Participants will explore cultural and structural conditions that promote and foster teacher leadership. We will reflect on leadership and how the leader's role supports sustainable change for student academic growth. The opportunity to dialogue with fellow leaders is embedded throughout the workshop.

Teacher Leadership II: Strategies and Tools for Differentiated Leadership Roles Thursday, May 15, 2008, 8:30-3:00

Leadership roles and strategies that provide growth for teachers and students will be explored. Participants will work with tools that will help to guide professional and instructional growth.

Professional Learning Communities I: Building a Team for Professional Development Thursday, November 1, 2007, 8:30-3:00

Participants will examine research to build a common understanding and language about professional learning communities. Tools such as agendas and protocols will provide practical frameworks for implementing and sustaining professional development within a learning community setting. Opportunities to explore first steps in building a team, as well as to reflect on next steps for your team, will be a focus of this workshop.



DEFERRED MAINTENANCE REVENUE PROVIDES OPTIONS FOR SCHOOL DISTRICTS

School districts not qualifying for Alternative Facilities Bonding (all but 21 districts statewide) received much needed help in the form of deferred maintenance revenue beginning with the 2007-08 school year. The maximum revenue under this statute, which for most districts is some combination of local levy and state aid, is \$60 per AMCPU. School districts qualified for either the maximum or a lesser amount based on the MDE's calculation of the ratio of the average age of building space within your district to 35 years.

Deferred Maintenance Revenue generated by the combination of levy and aid can be used for the following purposes:

- Health and safety projects without restriction to project size;
- Disabled access:
- Capital expenditures and maintenance projects necessary to prevent further erosion of facilities

Deferred revenue collected through levies and state aid must be held in a reserve account in the general fund and used only for eligible projects. In planning for deferred maintenance projects, districts have two options – "pay as you go" based on the district's highest priority needs and the balance available in the deferred maintenance account, or finance the improvement with Capital Facilities Bonds. The advantage of paying as you go with current revenues is avoiding interest and issuance costs. The advantage of financing eligible projects with Capital Facilities Bonds is tackling more expensive, high priority projects that could not otherwise be done on a timely basis. In the case of financing improvements, districts repay principal and interest on the bonds with revenue from the deferred maintenance levy and aid. In considering issuance of Capital Facilities Bonds for larger projects, it is important to remember two things. First, deferred maintenance revenue can only be used to repay principal and interest on the bonds for eligible projects as described above. Second, use of deferred maintenance revenue to finance Capital Facilities Bonds does not increase the amount of borrowing that a district can do under the Capital Facilities Bonding programs. However, use of bonds does provide greater flexibility in the use of operating capital revenue if the negative levy adjustments in the general fund offsetting the debt payments for a Capital Facilities Bond are charged to the deferred maintenance account for eligible deferred maintenance projects, thereby leaving more in the operating capital account for other purposes. Districts electing to finance larger deferred maintenance projects with bonds must meet the same requirements and follow the same procedures as any other issuance of Capital Facilities Bonds. The key steps are as follows:

- approval by the Commissioner of Education of proposed uses;
- review and comment for projects in excess of \$500,000 per school site;
- publication of notice of the intended projects, the amount of the bond issue, and the total amount of district indebtedness;
- subject to the districts; debt limit.

In terms of planning, districts that issue Capital Facilities Bonds for eligible deferred maintenance projects should also be aware of the following timelines:

- Projects in excess of \$500,000 per school site need to allow approximately 80 days for preparation, submission, and consideration of the required Review and Comment (123B.71, subd. 11&12).
- For all Capital Facilities and Equipment Bonds, as for all other general obligation bonds, the Commissioner of Education must authorize issuance of the bonds.
- Allow a minimum of 30 days between adoption of the resolution of intent and sale date in order to prepare official statement and meet other requirements including publication and the 30 day petition period.
- Assuming that the district has completed all requirements summarized above, it is recommended that your financial advisor be notified as soon as possible, but not less than 3-4 weeks before the meeting at which the school board will review recommendations and act on a resolution stating its intention to sell bonds.
- The closing on the sale is typically about four weeks after the school board approves the sale, at which time the bond proceeds are distributed to the school district.

EDUCATIONAL RESOURCE LIBRARY NEWS

Another school year is underway. Time seems to move so quickly.

The Educational Resource Library is the renamed combination of the Special Education Instructional Materials Center (SEIMC) and the Media Services Library. In this issue's article, I will focus on the media materials and services component of the Resource Library. Some people have had questions on what's been happening to the videos.

When we combined programs, we lost some things media patrons liked and used very much. The number of available videos dropped (storage space and limited usage), on-line searching and ordering (very expensive), door-to-door delivery (funding), and paying a fee per item used. We also gained some features: teacher requests by curriculum area and grade level, extended signout period (2 weeks), new materials on DVD format, and a single fee for all materials used. Subscribing districts can still order videos (catalog but no annotations), Science PACs and kits, Baby Think-It-Over Dolls, the Planetarium, and GPS units. Delivery is now on a weekly basis. For districts south of Marshall we contract with Plum Creek Library.

CHANGES IN VEBA PLANS...

The Minnesota Service Cooperatives, Blue Cross and Blue Shield of Minnesota, and SelectAccount are pleased to bring you the next generation of the VEBA plan. Your VEBA plan will now give you access to more investment options, while providing you with access to a new on-line investment site to help you manage your self-directed investments. And remember, if you decide that you'd rather not invest your VEBA dollars in mutual funds, you'll be happy to know that you can leave the money in your VEBA account and earn interest on the unused balance.

Why is the plan changing?

The Minnesota Service Cooperative's VEBA plan has grown dramatically since it was first introduced in 2004. Today, the plan includes more than 33 percent of all Service Cooperative groups and covers 12 percent of all account holders. Compared to the national average of less than 3 percent enrollment for consumer-directed health plans, that means your first generation VEBA plan has been quite successful.



So, why make any changes?

For starters, in the current VEBA arrangement, only 11 percent of members maintain an active investment account, despite the fact that they're all currently paying for this feature.

What's changing?

New investment program — On November 1, your self-directed VEBA investments will transition from a Wells Fargo investment arrangement to a new program powered by the world class, on-line investment management site of Schwab SRT, an on-line platform created by Charles Schwab & Company.

More investment options — VEBA investors now have access to 15 best-in-class mutual funds selected by Devenir LLC, a registered investment advisor.

A better service experience — As part of this new program, your existing VEBA account administrator SelectAccount, will also provide administrative customer service support for your self-directed investment account. When you have a support question like how to activate an on-line account, you have a familiar number to call where you will be recognized as a valued customer, a Minnesota Service Cooperatives member.

New trustee – As part of this transition, MG Trust will replace Wells Fargo as trustee of the VEBA. This change will have no direct impact on your account.

What do you need to do?

Your current Wells Fargo account will automatically transition in full to a new interest bearing account on November 1. There's no work required on your part to make the transition happen.

ARE STUDENTS BEING PREPARED TO MANAGE THEIR MONEY?

According to a Roper Poll commissioned by the American Institute for Certified Public Accountants (AICPA), 43 percent of Americans live above their means, spending \$1.22 for every dollar they earn. In 2003, 1.6 million Americans filed for bankruptcy, a number that has doubled since 1993 (360 Degrees of Financial Literacy, 2004.) Debt has become a personal finance crisis in America. What is being done to reverse this trend?

Thirty-two school districts in southwest and west central Minnesota recently took part in, what is believed to be, the most comprehensive study in Minnesota of K-12 students' knowledge of personal and business finance, and their saving and spending behavior. Over 3,725 sixth, ninth and twelfth grade students took part in the study. The study was authorized by the Center of Rural Entrepreneurship (CORE) and was funded through a Federal Congressional Earmark



Grant and a grant from the Southwest Initiative Foundation. Both the Congressional Earmark Grant and the grant from the Southwest Initiative Foundation were written by staff at the SW/WC Service Cooperative. Each school that participated in the study was mailed a comprehensive and confidential report that compared the results of their student surveys against the aggregate survey results.

The study was conducted by the Southwest Marketing Advisory Center (SMAC) with input from staff from the SW/WC Service Cooperative and the University of Minnesota Extension Service Regional Office in Marshall. SMAC is a self-funded entity within the academic marketing program at Southwest Minnesota State University (SMSU). It's mission is to service the marketing and research needs of southwest Minnesota while giving "real-world" experience to the Junior, Senior and Graduate level student employees. The Center was founded by its Executive Director, along with the assistance of two Senior level marketing students in 2002. Never using grants or university dollars during its six years of service to the area, SMAC has completed over 210 client projects.

Some conclusions from the K-12 personal and business finance study include:


- The majority of 6th and 9th graders receive most of their money from their parents or family members, the majority of 12th graders work for most of their money
- 6th graders are more likely to save a larger amount of their money than 12th graders
- Eighty percent of 12th graders save their money in a bank
- 12th graders were most likely to have a checking account, however, the responses in this study indicated 6th graders were more likely to have a checking account than 9th graders
- Approximately 20 percent of 12th graders carry a credit card, among those that have a card, 80 percent use it and 60 percent indicated they pay the balance on the credit card each month
- Students self-reported a perception of having a high level of understanding with reading, writing, and math; while having the least amount of understanding with business finance and personal finance
- Students perceptions of their abilities in the areas of business and personal finance are significantly higher than their actual scores in these areas

Regional organizations and programs such as CORE, Junior Achievement, Students in Free Enterprise, University of Minnesota Extension Service, Southwest Initiative Foundation, Regional Development Commissions, Professional Student Organizations, K-12 School Districts and others will use the results of this study, along with other regional data, to help promote and implement Personal Finance and Free Enterprise Education to students in the 18-county service area. "To say I was shocked would be an understatement. I was stunned. It was like being hit by a baseball bat."

The early times after the diagnosis of your child's hearing loss are often the toughest part of the whole journey. A 2001 creation of Lifetrack Resources, the Family Support Connection - Minnesota Hands and Voices - is a private non-profit program whose mission is to provide a variety of unbiased support services to families of children who are identified with hearing loss. MN Hands and Voices provides **parent-to-parent support** to families of children diagnosed as deaf or hard of hearing. MN Hands & Voices staff are parents of children who have hearing loss. They share the same emotions, decisions and questions as the families they serve and are committed to providing a balanced look at raising a child who is deaf or hard of hearing. All staff have a strong belief that it is the parents who know what is best for their child. Parents simply need enough information to make sound, informed choices.

MN Hands and Voices has been active in our own SW/WC Service Cooperative Region. They have provided unbiased parent support by connecting families with children of all ages and types of hearing loss, co-sponsoring and attending family networks, offering parent-to-parent guides, and giving access to many resources through their lending library of books, videos and other materials, so that families can learn more about their child's hearing loss.

NOMINATIONS SOUGHT FOR 2008 OUTSTANDING EDUCATOR AWARD

The WEM Foundation and the Center for Academic Excellence (CAE) invite you to help recognize and honor the outstanding K-12 educators who help make Minnesota a national leader in teaching and learning.

CAE is accepting nominations for the tenth annual WEM Foundation Outstanding Educator Awards in three categories: Academic Challenge Coach of the Year (for outstanding coaches of activities endorsed by Minnesota's Academic League Council), Teacher Achievement (for teachers who excel in advancing student learning in challenging or alternative settings), and Ethics in Education (with individual and team recognitions for promotion of ethical behavior in school curriculum or policy and personal practice). Currently-practicing educators from public and non-public schools, including public charter schools, are eligible for nomination. Nominations are particularly encouraged from students, parents and colleagues.

The Center for Academic Excellence and the WEM Foundation work in partnership with the service cooperative members of the Minnesota Regional Service Agency (MRSA), to administer this program on a statewide basis. (CAE is a non-profit organization that delivers statewide student and educator recognition programs.) A blue-ribbon judging panel will name six state honorees and regional finalists to help showcase academic excellence in Minnesota. Each state honoree will receive an unrestricted \$10,000 prize from the WEM Foundation, to honor the "unsung heroes" of the education profession.

2007 CONFERENCE KICKS-OFF THE SCHOOL YEAR FOR 1,550 EDUCATION PROFESSIONALS



The 2007 Teaching and Learning Conference kicked off with keynote speaker Pat McGill motivating a crowd of 1,550 with humorous stories and practical advice that every educator could relate to. This was the third annual event and has grown from 820 in 2005 and 1,250 in 2006. Twenty-six public and private school districts, Southwest Minnesota State University, and Minnesota West Community and Technical College partner with the SW/WC Service Cooperative to plan and hold the event. This year's event was held at the Marshall High

School in Marshall. Conference participants chose from a menu of 93 breakout session titles that covered all grade levels and disciplines. Additionally there were 40 educational vendors available to participants throughout the day.

Year-in and year-out, the most talked about highlights of the conference are the networking sessions. Each participant registers for a small group networking session with other educators that teach at their grade level and/or discipline area. Over 80 facilitators were trained prior to the conference to lead their group through the session. This formalized networking time provide teachers a chance to share curriculum ideas, discover new resources, and seek input and support from colleagues. Networking doesn't have to stop after the conference; nearly 1,400 educators are registered for the "Teacher to Teacher" on-line networking site (found at www.educatorcom.com). The site provides an electronic forum for teachers to share and receive news, have bulletin board discussions, and share relevant websites based on their educational discipline.

The SW/WC Service Cooperative would like to thank each participating school district, the conference advisory committee, and the conference sponsors for making the 2007 Teaching and Learning Conference a big success! Planning for the 2008 event will soon be underway.
