ITEM 1: CALL TO ORDER

Chair Coleman called the meeting to order at 5:00 pm at SWWC – Marshall, MN &

ITEM 2: INTRODUCTION OF NEW BOARD MEMBERS

Incoming board members Carla Olson, Ben Bothun, and Becky Foster were welcomed

and introduced.

ITEM 3: AGENDA APPROVAL

Motion by Steve Schnieder, seconded by Jody Bauer, to approve the agenda as presented. A roll call vote was taken with Directors Coleman, Bauer, Schnieder, Olson,

Bothun, and Foster voting in favor. Motion passed unanimously.

ITEM 4: ORGANIZATION OF THE BOARD

4.1 Election of Officers

Chair Coleman called for nominations for Chair. Steve Schnieder nominated Matt Coleman. Jody Bauer seconded the nomination. Chair Coleman called three times for further nominations; none were made. Motion by Steve Schnieder, seconded by Jody Bauer, that nominations cease, and the secretary cast a unanimous ballot for Matt Coleman for Chair. A roll call vote was taken with Directors Bauer, Schnieder, Olson, Bothun, and Foster voting in favor. Director Coleman abstained. Motion passed unanimously. Matt Coleman was elected as Chair.

Chair Coleman called for nominations for Vice Chair. Matt Coleman nominated Jody Bauer. Steve Schnieder seconded the nomination. Chair Coleman called three times for further nominations; none were made. Motion by Matt Coleman, seconded by Steve Schnieder, that nominations cease, and the secretary cast a unanimous ballot for Jody Bauer for Vice Chair. A roll call vote was taken with Directors Coleman, Schnieder, Olson, Bothun, and Foster voting in favor. Director Bauer abstained. Motion passed unanimously. Jody Bauer was elected as Vice Chair.

Chair Coleman called for nominations for Clerk. Matt Coleman nominated Steve Schnieder. Jody Bauer seconded the nomination. Chair Coleman called three times for further nominations; none were made. Motion by Matt Coleman, seconded by Jody Bauer, that nominations cease, and the secretary cast a unanimous ballot for Steve Schnieder for Clerk. A roll call vote was taken with Directors Coleman, Bauer, Olson, Bothun, and Foster voting in favor. Director Schnieder abstained. Motion passed unanimously. Steve Schnieder was elected as Clerk.

Chair Coleman called for nominations for Treasurer. Steve Schnieder nominated Carla Olson. Matt Coleman seconded the nomination. Chair Coleman called three times for further nominations; none were made. Motion by Steve Schnieder, seconded by Matt Coleman, that nominations cease, and the secretary cast a unanimous ballot for Carla Olson for Treasurer. A roll call vote was taken with Directors Coleman, Bauer, Schnieder, Bothun, and Foster voting in favor. Director Olson abstained. Motion passed unanimously. Carla Olson was elected as Treasurer.

4.2 Designation of Official Newspaper

Motion by Jody Bauer, seconded by Steve Schnieder, to adopt a resolution designating the Marshall Independent as the official newspaper for 2024. A roll call vote was taken with Directors Coleman, Bauer, Schnieder, Olson, Bothun, and Foster voting in favor. Motion passed unanimously. Minutes of the SWWC Board of Directors meeting will be published on the agency website.

4.3 <u>Designation Regarding Annual Fiscal Requirements</u>

Motion by Steve Schnieder, seconded by Jody Bauer, to designate depositories for SWWC as presented by resolution; to adopt the resolution for facsimile signatures as presented; to appoint the Executive Director and/or the Director of Finance to perform the duties of the Treasurer between meetings; to appoint the Executive Director, the Director of Finance, Board Secretary, and Executive Assistant to safeguard the facsimile signature of the clerk and chair and to use them for the signing of checks, warrants, and contracts as authorized by the Board; and to authorize the Executive Director, the Director of Finance, the Accounting Specialist, and the Accounting Technician to order wire transfers between approved financial institutions according to directions from the Executive Director or the Director of Finance. A roll call vote was taken with Directors Coleman, Bauer, Schnieder, Olson, Bothun, and Foster voting in favor. Motion passed unanimously.

4.4 Board Stipends/Mileage

Motion by Steve Schnieder, seconded by Jody Bauer, to establish SWWC Board stipends and mileage payments for 2024 as follows:

Per Diem – Board salary of \$100.00 per month

<u>Insurance Allowances</u> – Dental – Single or Family -- \$40.00/month

Board Meeting Stipend

- \$200.00 per Board Meeting payable also when board members joins virtually
- \$35 additional stipend paid Board Chair for regular or special Board Meetings attended
- \$15 additional stipend paid Board Clerk for regular or special Board Meetings attended

Board/Committee Meeting Mileage

- Mileage per federal IRS guidelines plus \$.40 per mile "windshield time".
- "Windshield time" will also be paid Board members riding with another person

<u>Conferences/Workshops/Meetings/Committee Meetings (held on non-board day)</u>

- \$200.00 per full day (over 4 hours, including travel time) or \$100.00 per half day (less than 4 hours, including travel time) for representing the Board at meetings, conferences, workshops; mileage per federal IRS guidelines; meal reimbursement per SWWC guidelines
- \$200.00 per full day (over 4 hours, including travel time) or \$100.00 per half day (less than 4 hours, including travel time) for serving on regional or state committees on behalf of SWWC if not paid by hosting agency; mileage per federal IRS guidelines if not paid by hosting agency
- Stipend and mileage will not be paid unless a Board member is specifically asked to be a presenter or a representative of the SWWC at SWWC or other meetings unrelated to actual SWWC Board business
- Board members attending MREA will be reimbursed mileage, but will not be paid a stipend; board member's local district will be encouraged to pay MREA dues plus lodging

A roll call vote was taken with Directors Coleman, Bauer, Schnieder, Olson, Bothun, and Foster voting in favor. Motion passed unanimously.
